Narrative - Mcginnis, Jeffery A - 3/26/2021 (Initial)

On this day I was dispatch to Dacus at 211 church Street for assault in progress, when I arrived Kayla Moore let me in the facility and advised me that [REDACTED] had been acting up and when they tried to get him to stop [REDACTED] punched another child in the face and then turned on her as she tried to get him to stop, she continued to say that she had called for help and that's when Shayna Beck arrived to help her. (See Kayla's Statement).

I then spoke to Shayna Beck and I could see some redness to her chest and ask her what had happened and she said that Kayla and she tried to make [REDACTED] stop acting out and he turned on her and was punching her and that was the reason for her chest being red. (See Shayna's statement)

I talked with [REDACTED] and ask how come he was fighting staff and he said because they was trying to punish him for acting out and he was not going to let them. I contacted Juvenile Officer on call and advised her what had happened and that the staff wanting him prosecuted and she advised me to tak him to Detention. [REDACTED] was placed
