Narrative - Fraser, Jason - 7/24/2021 (Initial)

On 7/23/2021 I Officer Fraser Responded to Complainant (Dacus Residential Treatment Center) for a report of employees assaulted. I arrived on scene and met with Victim #1 (Moore, Kayla Leann) and Victim #2 (Patton, Sydney Leann). They wanted a report made on Suspect #1. Suspect #1 was outside with peers playing basketball when he become verbally aggressive. They advised me he was calling peers "fat ass" And saying he was going to kill them. He made a statement to staff that he was going to run. Both Victim #1 (Moore, Kayla Leann) and Victim #2 (Patton, Sydney Leann) began to atempt to restrain him . Victim #1 (Moore, Kayla Leann) was head butted by Victim #1 (Moore, Kayla Leann) He continued to try to pull away as they attempted to restrain. He began hitting both staff members. Victim #2 (Patton, Sydney Leann) was head butted as well during the scuffle and her tooth punctured her lip. She did refuse ems treatment and transport. By the time they had in restrained both staff member were bleeding from lips.

I made contact with Juvenile Probation Officer Powell in reference to his case. [SUSPECT1 was placed] in custody and transported to Craighead County Detention Center.
