Narrative - Jones, Joe - 7/19/2019 (Initial)

On July 19, 2019 at approximately 2058 hours, I (Officer Jones) was dispatched to MillCreek in reference to an ambulance assist. Upon arrival I observed a group of individuals standing over a male subject that was lying face down.

I was informed by the supervisor Jermarrio Stephens that the subject became combative with staff and they had to physical restrain him. Mr. Stephens stated when they tried to let him up, he became unresponsive and began to shake. Mr. Stephens stated that is when they contacted the ambulance.

The ambulance arrived on scene and took over and the paramedics placed the subject in the ambulance. Paramedic Mike Rowe stated it appeared the subject had a concussion.

I learned the patient to be [REDACTED] and Mr. Rowe stated while en route to the hospital he complained of the back of his head hurting. [REDACTED] was transported to the Dallas County Medical Center for further treatment.


The child abuse hot line was contacted and advised of the incident. The case number is 1989244.
