Narrative - Cutrell, John - 9/23/2019 3:06:00 PM (Initial)

On September 23, 2019 at approximately 1506 hours this officer, John Cutrell, was dispatched to Mill Creek for a subject taking pictures of the facility.

Upon arrival I made contact with Dewayne Brewer a Mill Creek employee. Mr. Brewer stated that a lady was taking pictures and she wouldn't identify her self to him. Mr. Brewer stated he wanted her gone because she was trespassing. I advised Mr. Brewer that she was parked on the side of the road and was on a public roadway.

This officer made contact with a white female that she identified her self as Stacey Wescott. Mrs. Wescott stated that she works for the Chicago Tribune and she was doing a story on Mill Creek. Mrs. Wescott stated that she wasn't taking any pictures or videos of any of the workers or children. Mrs. Wescott stated that she was just about finished on what she had to do and then she said she would leave.

I advised Mr. Brewer of who she was and what she was doing. I advised Mr. Brewer that Mrs. Wescott was fixing to leave. And that I couldn't tell her to leave because she was on public property and wasn't obstructing traffic.
