Narrative & Statements

Narrative - Bryant, Austin - 2/4/2020 (Initial)

On February 4, 2020 at approximately 1839 Hours I, Officer Bryant, was dispatched to Mill Creek of Arkansas for a report of up to 3 runaways.

While en route to Mill Creek I noticed two males; one black male and one white male, walking south on Highway 79. I stopped these two individuals who were later identified as [REDACTED] and [REDACTED]. These individuals were identified as two of the three that had ran away from Mill Creek. These two individuals were handcuffed and transported to Mill Creek. Upon arrival at Mill Creek while uncuffing both boys [REDACTED] became belligerent and combative and started threatening me saying that he would kill me and that he was going to fight the workers at Mill Creek and other residents. [REDACTED] was transported to the Fordyce Police Department. I made contact with Juvenile Officers Mr. Paul Hall and Ms. Becky Kathy; both of these officers advised me that they could not do anything with [REDACTED] tonight. [REDACTED] was then transported back to Mill Creek of Arkansas.


Upon a later call dispatch was advised that [REDACTED] had been found by one of the workers and was back at the facility.
