On February 5, 2020 at approximately 1837 Hours I, Officer Bryant, was dispatched to Mill Creek of Arkansas for a runaway.

Upon arrival I spoke with Nurse Paula Smith who advised me that the individual's name that ran away was [REDACTED] white male, 16 years of age and was last seen in grey sweatpants and a grey sweatshirt. Mrs. Smith advised me that he was last seen running south towards Fordyce.

Dispatch was advised by Dispatcher Jerri Shuller from the Dallas County Sheriff's Office that a Dallas County Deputy had caught [REDACTED] and transported him back to Mill Creek.


