Narrative & Statements

Narrative - Davis, Chad - 3/15/2020 (Initial)

On Sunday, March 15, 2020 at approximately 4:00 PM, I, Officer Davis made contact with Christina Willis at 626 E. Broadway in reference to her seven year old child being kissed inappropriately by another female juvenile, (13 years old), at Perimeter Behavioral Hospital.

Willis stated that she was contacted by a subject known only as Ron who stated that he was a nurse with the facility and informed her of the incident. Willis stated that contacted by the CEO of the hospital and advised that her daughter was moved into a private room after the incident. She was also advised that staff had checked the cameras of the facility in the area where her daughter stated that it happened and were unable to locate any video of the incident.

Willis filled out a written statement and was advised to contact CID and that a report would be on file.

Narrative - Dixon, Lauryn - 3/18/2020 (Investigative)

There is no video footage of this incident where victim claimed it happened. The suspect is denying this claim. This case will be filed.
