On March 22, 2020 at approximately 1624 hours, I (Officer Jones) and Officer Swiger were dispatched to Millcreek in reference to an escape juvenile.

Upon arrival I made contact with the nurse Susan Sisson, who stated [REDACTED] had ran away and he was wearing blue shirt blue jeans and a red jacket. I was informed he ran towards Johnson Warehouse. While en route I was informed [REDACTED] had been spotted on Gober Road. When we arrived on scene, I spotted the subject in the woods. I was able to talk [REDACTED] and convince him to go back with the workers at Millcreek. [REDACTED] was turned over to the workers and I checked back in service.
