Narrative & Statements

Narrative - Bowman, Gregory - 3/29/2020 (Initial)

On 03/29/2020, approximately 5:18 PM, I, Officer Bowman #282 and Blazin #259, was dispatched 600 North 7th street in reference to seven runaway juveniles.

Upon my arrival I made contact with the Complainant/Jerome Woods. Woods stated that earlier in the day he was informed by staff members that the Suspects [REDACTED] planned to attack another girl at the facility and incite a riot in order to escape. Woods stated that [REDACTED] attacked another girl by the name of [REDACTED]. While the incident took place [REDACTED] ran towards the nurses front desk station and managed to swipe a key card allowing them to have access to the facility doors. Once they acquired the key card [REDACTED] and [REDACTED] opened the back entrance to the facility allowing the other listed girls to run away from the facility as well. Seven of the girls managed to escape to the area of the 1100 block of East Barton where Officers Manning #272, Johnson #235, Kohl #259, Doss #281, Shelton #263, Griffin #289 made contact with all the suspects. The suspects were then detained and transported back to 600 North 7th.
