On April 3, 2020 at approximately 2029 hours I (Officer Canaan Swiger) was advised by dispatch of a non-emergency call being transferred to my phone.

When the call was transferred, I spoke with RN Judy Mosley from Dallas County Medical Center in regards to a young boy from Millcreek Behavioral Health identified as [REDACTED]. RN Mosley informed me of the bruises on Mr. [REDACTED] which had been caused by a fight between [REDACTED] and two other male subjects at Millcreek Behavioral Health. I was advised [REDACTED] had

injuries to his face.

I asked RN Mosley if I could talk with [REDACTED] to get his statement on what had happened and she advised me to wait so she could get him on the phone. When [REDACTED] picked up the phone, I introduced myself and began to ask him what had happened. [REDACTED] stated two young boys from Millcreek beat him up, these young boys were identified as [REDACTED] and [REDACTED]

[REDACTED] stated after he had eaten dinner, he was outside and [REDACTED] and [REDACTED] came up behind him and began to attack him for no apparent reason. I advised [REDACTED] a report would be made of this and explained to him if he would like to pursue charges against [REDACTED] and [REDACTED], he would need to contact Dallas County Court House for assistance in that matter.

After I finished explaining that to [REDACTED] he passed the phone to his supervisor identified as Tracy Crain which I explained the procedures of pursuing charges to him as well to ensure that if desired [REDACTED] would have help in that matter. I then checked back in service.
