On May 2, 2020 at approximately 1544 hours, I (Officer Jones) was dispatched to Millcreek in reference to four juveniles escaping from the facility.

Upon arrival I was advised by Nurse Donna Stevens that two to of the juveniles had been caught. Ms. Stevens advised the two that were not counted for was [REDACTED] and [REDACTED] Ms. Stevens didn't know how long they had been gone or what they were wearing. Ms. Stevens stated the subjects did leave running towards Pine Bluff.

I searched the area and was unable to located anyone. I checked back in service.
