## Narrative & Statements

### Narrative - Manning, Thomas - 5/7/2020 (Initial)

On May 7, 2020 at approximately 8:39 P.M., I, Officer T. Manning #233 was dispatched to 600 North 7th in regards to a patient who had over dosed. Upon arrival I made contact with LPN (Janeen Harris) who stated that patient [REDACTED] had reported to staff that she had been cheating her medicine and taken 4 (400 MG) pills of her prescription pills Seroquel. While speaking to [REDACTED] she seem to be alert and conscious of the decisions she had made but also dizzy and confused. [REDACTED] was seen by West Memphis Fire and transported to Baptist Crittenden to be check out by medical staff.
