Narrative - Cutrell, John - 5/24/2020 9:40:00 PM (Initial)

On May 24, 2020 at approximately 2140 hours this officer, John Cutrell, had a phone call transferred from dispatch.

This officer made contact with Justin Weldon and he stated that last night around 2150 hours a staff member allowed two patience go in the bathroom to have sex. The black female was [REDACTED] and the black male was [REDACTED]. Mr. Weldon stated that the staff member knew what the two patience's were going to do. Mr. Weldon said that around 2330 hours the same staff member that was named Kristian Matthews entered [REDACTED] room and began to touch her in her private area. Mr. Weldon also said that Ms. [REDACTED] stated that Mr. Matthews exposed himself to her.

Mr. Weldon said that he viewed the video footage and verified what [REDACTED] stated. He saw Mr. Matthews enter her room. Mr. Weldon said he had already contacted the Child abuse hot line and was unable give me the case number because he had faxed them the paperwork on the incident.

Narrative - Rhodes, Michael - 5/26/2020 (Initial)

On May 26, 2020 at approximately 1300 hours Investigator Jennifer Harper with the Arkansas State Police / Crimes Against Children Division arrived at the Fordyce

Police Department in regards to a sexual assault that happen at Millcreek of Arkansas. I made contact with Investigator Harper and she advised me of her investigation. Investigator Harper stated that she had interviewed the victim and other patients at Millcreek. Investigator Harper stated that she does believe the victim and the video that she saw showed Mr. Mathews going into the victim's room for several minutes. Investigator Harper stated that she was on the way back to her office but would get a copy of her report to me.

Narrative - Rhodes, Michael - 11/12/2020 (Initial)

On November 11, 2020 at 0825 I was advised that Cleveland County Sheriff Department was finished with the charges on Krystan Mathews and that our agency had a hold on the subject. I advised Cleveland County Sheriff Department that I would have an officer en route to pick Mr. Mathews up.

I made arrangements with Dallas County Detention Center and had Officer Cutrell to transport Mr. Mathews from the Cleveland County Detention Center to the Dallas County Detention Center to be housed until his first appearance.

Narrative - Rhodes, Michael - 11/12/2020 (Initial)

On the 12th of March 2020, Krystan Mathews was taken before Judge Ronnie Phillips for his Judicial First Appearance on the charges of Sexual Assault in the Second Degree.

Judge Phillips determined from the affidavit of arrest that probable cause existed and bound this case over to the Circuit Court of Dallas County.

Mr. Mathews was given a \$100,000.00 bond. Judge Phillips also placed restrictions on Mr. Mathews if he posted bond and they are as follows;

1. Good Behavior (No Law Enforcement Action and No alcohol or drugs).
