Primary Narrative By Calvin Davidson, 05/24/20 12:15

Assault

On Sunday 5-24-20 at 0855 hours, I responded to 20400 Colonel Glenn (Youth Home) in reference to an assault.

Upon arrival. I made contact with Brian Banks the complaint and employee who said on this date he informed she needed to go to her room and eat her breakfast. Banks said refused to comply with his request and retrieved a plastic knife from the kitchen at an unknown time. Banks said he the escorted to her room where she pulled the plastic knife out of her pocket and lunged at him with it. Banks said another staff member, Reagan Bell was able to knock the knife out of hand to prevent any further incident.

Banks said staff was then able to calm and wait for our arrival.

It was then learned that had attacked another youth on 5-23-20 (See Nichols Supplement) and had suffered a broken hand during another past incident and had removed the cast. ______ is being treated for disruptive mood dysregulation disorder, unspecified trauma, attention deficit, unspecified problems related to social environment, and other stressor related disorders.

Mems unit 709 responded and transported Children's Hospital for treatment.

Banks was given the report number and advised to contact the Prosecuting Attorney office for further assistance.

Supporting Narrative By Terri Nichols, 05/24/20 12:00 Battery

On 5-24-20, I (Deputy Nichols) responded to 20400 Colonel Glenn Road to assist Deputy Davidson in reference to an aggravated assault.

Upon arrival, I observed Dep. Davidson speaking with Brian Banks (victim) in reference to an assault. While on scene, staff personnel advised that a 13 year old female had been battered the night before by the same subject that assaulted Banks. The staff said that it was not reported to law enforcement.

At this time, I made contact with the female staff identified as the suspect for both incidents

complied with my requests to speak with her but initially appeared to be very upset as she did not talk and began to cry. When asked what happened with the incident involving a knife, she said that she and Banks were engaged in a verbal altercation before he requested her to eat her food in her room when she didn't want to. The altercation escalated when she said she grabbed a plastic knife with the intentions of keeping everyone away from her. She was then grabbed by Banks and forced into an isolation room.

When asked about the incident involving she said that they were arguing around 2030 hours the night before because continues to cause problems in the home (they are not in the same unit). The argument escalated when said that she threw a shoe at her and then began to hit her several times by striking her with her fists.

The battery was not reported until today due to reporting head pain and blurred vision. When asked about the issue of not reporting, personnel advised that the incident occurred under the supervision of a different shift (night shift comes in at 1900 hours).
