Narrative - Rhodes, Michael - 6/24/2020 (Initial)

On June 22, 2020 at approximately 1130 hours I received a notice in the mail from Investigator Kim Gill with the Arkansas State Police Crimes Against Children in reference to a rape. I made contact with Investigator Gill and she stated that through her investigation so far she doesn't believe it happened. Investigator Gill did say that she hasn't completed her investigation yet but did advised me that the victim did go to the Arkansas Children Hospital to have an exam. Investigator Gill did say that a sexual assault kit was completed and is at Childrens Hospital. Investigator Gill stated the she is not able to pick it up. Investigator Gill stated that we could go pick the kit up at any time and that when she completes her investigation she will send me a copy of her report. I advised Investigator Gill that I would be waiting for the report.

On July 30, 2020 at approximately 1330 hours I received a letter from Kim Gill with Arkansas State Police Crimes Against Children. The letter states the following:
