On 7-28-2020 I Officer Adrian Todd was dispatch to WoodRidge in reference to 2 juveniles running away. Upon arrival I spoke with the nurse, he stated that [REDACTED] and [REDACTED] jumped the back fence and ran. I asked the nurse what did he have on and he advised me that he did not know. The nurse stated [REDACTED] is a black male [REDACTED] height and [REDACTED] pds. [REDACTED] is a white male red hair red beard [REDACTED] height and [REDACTED] pds, No one could give a clothing description of both juveniles, nor a direction of travel.

The juveniles were returned safely back to the facility by the St. Francis County Sheriff Deputy.
