On July 28, 2020 at approximately 12:53 am, I Officer Shane Andrews arrived at 603 Kittle Rd in reference to some missing (residence) juveniles at the facility. Upon my arrival, I spoke with Ms. Leeann Barton the register Nurse who was on duty. Ms. Barton stated that approximately 15 mins prior to me arriving, they were checking on all the juveniles. She stated there was four in a room together and all four were missing.

In there room they found the A/C pulled out and the kids crawled out of the window unto the outside of the facility where they escaped. She stated 2 juveniles were white males, one of them was named [REDACTED] approximately [REDACTED] tall with a low hair cut and his hair was brown in color with blue eyes.

The second was [REDACTED] approximately [REDACTED] with a low hair cut as well but no other description. They were unsure what clothes they were wearing, stating that may have obtain clothen underneath their actual uniform. The other two juveniles were black males, one being [REDACTED] light skin complexion with freckles wearing a green jump suit. The other one was [REDACTED] also wearing a green jump suit and he will be bigger then the other three juveniles.

It is unknown their direction of traveling, and if officers come in contact with the 4 juveniles, all four have tested positive for the Covid-19. Officer checked with a local radius for the juveniles, on Lindauear road, Kittle road and 284 near both colleges for the juveniles. The immediate supervisor on duty (Sergeant Ivey) checked on the staff twice to see if the juveniles had return, and as of previous they had not return.
