On August 14, 2020 at approx. 12:47 I, Ptl. Williams was dispatch to 603 Kittle, WoodRidge in reference to 2 juveniles running away. Upon arrival, I spoke with the nurse that stated that [REDACTED] and [REDACTED] jumped the back fence by the basketball court and ran. I asked the nurse what did they have on and he advised me [REDACTED] had on a black shirt with red pants; [REDACTED] had on a green shirt and grey pants. The nurse stated [REDACTED] is a black male with curly hair and [REDACTED] is a white male with Brunette hair with facial hair and he can be mistaken as an adult.
