On September 19, 2020 at approximately 1725 hours this officer, John Cutrell, was dispatched to Mill Creek for a subject that had run away.

While en route to Mill Creek there were three mill creek workers in the vehicles on the side of the road in the 1700 block of Highway 79. The workers stated that the white male walking towards town was the one that ran away. Myself and Officer Hubanks located the subject walking on the side of the road. Officer Hubanks made contact with him and placed him in the back seat of his patrol car. Officer Hubanks transported the male subject back to Mill Creek.

The male subject was identified as [REDACTED] [REDACTED] said he left the campus because he wanted a cigarette. [REDACTED] was released back in to the care of Mill Creek.
