Narrative - Wood, Roger - 9/20/2020 (Initial)

On September 20, 2020 at approximately 1330 hours myself (Officer Wood) along with Officer Swiger were dispatched to Highway 79 near Industrial Drive in reference to an escape from Milcreek Behavioral Institute.

Upon arrival we made contact with both male subjects so we got out to assist the Milcreek workers. I took one black male subject and placed him in my unit. After securing the first subject I went to help Officer Swiger. Officer Swiger placed the subject on the ground and attempted to handcuff him. The subject had both arms under him and was resisting. I placed the palm of my hands on the subject's shoulder blades in an attempt to get him to release his arms. With the assistance of a Milcreek employee we were able to handcuff the subject. Officer Swiger placed him in the back of his unit. Both subjects were transported to Milcreek.
