Narrative - Swiger, Canaan - 9/29/2020 11:59:00 AM (Initial)

On September 29, 2020 at approximately 1159 hours I (Officer Swiger) was dispatched to Milcreek Behavioral Institution for a subject removal of an employee.

Upon arrival I made contact with Ms. Pam Buford. Ms. Buford stated that an employee was yelling at the supervisor in his office then the employee was taken to the CEO's office that way they could calm him down. I asked if I could speak to the supervisor Ms. Buford stated yes and took me to Mr. Kelcey Highsmith's office. Mr. Highsmith stated that the employee's name that was yelling at him was Mr. Mark Jackson. Mr. Highsmith stated that Mr. Jackson came in his office very upset due to the fact Mr. Highsmith sent him home yesterday and stated they would call him today to let him know about his job status. Mr. Jackson was confused about the situation so he came up to Milcreek to get some answers. he started yelling at Mr. Highsmith in attempt to tell him how he didn't agree with his decision Mr. Highsmith stated he attempted to talk to him and calm him down however Mr. Jackson told him to "Shut Up". Mr. Highsmith contacted the CEO of Milcreek Mr. Brady Serafin. Mr. Serafin took Mr. Jackson to his office in an attempt to calm him.

After completing talking with Mr. Highsmith I made my way to the CEO's Office to make contact with Mr. Jackson. Upon arriving to the office Mr. Jackson told me his side of the story where he advised me that they had sent him home due to the fact he made a comment in training that everyone here lies. Mr. Jackson admitted to yelling and telling Mr. Highsmith to shut up and that he was out of order but he was frustrated about the situation. I advised both parties about the affidavit procedures and to call Dallas County Court House if they wished to proceed with them. Mr. Jackson was advised to leave due to fact he was there unlawfully and if he didn't leave, he would be charged with Criminal Trespass and Disorderly Conduct. Mr. Jackson left on his own and stated he wouldn't come back until he was asked to do so by Milcreek.
