NARRATIVE

OFFICERS RESPONDED TO A ASSAULT JUST OCCURRED CALL AT 6501 W 12TH STREET, UPON ARRIVAL OFFICERS MADE CONTACT WITH CALESHA BALLOU, AN EMPLOYEE OF CENTERS OF YOUTH AND FAMILY, WHO ADVISED JUV1 STRUCK HER IN THE CHEST AFTER REFUSING TO DO SOMETHING THAT WAS ASKED OF HER. OFFICERS WERE ESCORTED TO THE BACK TO MAKE CONTACT WITH JUV1. AS JUV1 WAS WALKING INTO THE ROOM, SHE TURNED AND PUNCHED LAWELL CROSBY, ANOTHER EMPLOYEE OF CENTERS OF YOUTH AND FAMILY, IN THE LEFT ARM. MRS. BALLOU AND MR. CROSBY STATED JUV1 THREATENED TO "BEAT THEIR ASSES". JUV1 WAS TAKEN INTO CUSTODY WITHOUT INCIDENT. JUV1 STATED TO OFFICERS SHE HAD INTENTIONS ON HARMING HERSELF WHEN GIVEN THE CHANCE. BOTH BALLOU AND CROSBY REFUSED MEDICAL ASSISTANCE AND WERE GIVEN INCIDENT NUMBERS. AS JUV1 WAS BEING ESCORTED TO THE PATROL VEHICLE, SHE KICKED MRS. BALLOU IN THE RIGHT LEG. SHE WAS PLACED IN THE PATROL CAR AND MEMS WAS NOTIFIED. OFFICER FARNAM CONTACTED SGT. JOHNSTON. AS MEMS ARRIVED ON SCENE, OFFICER FARNAM CONTACTED JUVENILE INTAKE AND SPOKE WITH LAURA ROBERTSON, WHO ADVISED TO GIVE HER A COURT DATE OF NOV. 16, 2020 AT 0930 HOURS. JUV1 WAS TURNED OVER TO MEMS #83, WHO TRANSPORTED HER TO CHILDRENS HOSPITAL FOR ACUTE CARE. OFFICERS CONTACTED THE MOTHER OF JUV1. MEGAN WINGETT, TO NOTIFY HER ON THE EVENTS THAT HAD OCCURRED AND THE STEPS THAT WERE BEING TAKEN. MRS. WINGETT WAS ADVISED OF THE CITATION TO APPEAR IN COURT AND WAS GIVEN THE COURT DATE AND TIME. JUV-1 WAS CHARGED WITH BATTERY 3RD DEGREE, ASSAULT 3RD DEGREE AND 2 COUNTS OF TERRORISTIC THREATENING ON CRIMINAL CITATION CR200227. DUE TO MRS. WINGETT LIVING OVER 3 HOURS AWAY, THE CITATION WAS EMAILED AS WELL AS PHYSICALLY MAILED TO HER RESIDENCE. MVR IN USE.
