Narrative

On Saturday, October 17, 2020 approximately 2123 hours (9:23pm) I was dispatched to 161 Skunk Hollow Road for a runaway juvenile. While enroute I received a call stating the juvenile was heading North on Skunk Hollow Road toward Highway 64 East. We received this call from Mr. Anthony Deloney, (victim/complainant) an employee of Little Creek Behavioral.

I found JO1 walking just North of Middle Road on Skunk Hollow Road. JO1 was compliant and willingly entered my patrol unit for transport back to the facility. JO1 stated she had a key and was able to just walk out of the facility. JO1 was successfully transported without incident to Little Creek Behavioral and was returned to staff.

Mr. Deloney advised me he already contacted JO1's guardians. I gave this report number to Mr. Deloney and advised how to obtain a copy. Body Camera footage of this incident exists and will be uploaded.
