On October 18, 2020 approximately 2040 Hours I was dispatched to Mill Creek of Arkansas for a riot at the Pine Ridge Unit. Upon arrival I spoke with Brittany Riggans and she stated that three boys, [REDACTED] and [REDACTED] started a riot by throwing food, cursing, yelling and running around without obeying the commands of staff. I located the three subjects and detained them in handcuffs. [REDACTED] was the main subject that started the incident and was still being disruptive. [REDACTED] was taken to my patrol unit to calm down. [REDACTED] and [REDACTED] calmed down after removing [REDACTED] from the building. [REDACTED] and [REDACTED] were given shots to allow them to go to sleep for the night. Kelsey White arrived on scene and was advised of the situation. I removed [REDACTED] from my patrol unit and released him to Mr. White.
