Narrative

On Saturday, October 24, 2020, at approximately 13:22 hours, I responded to 161 Skunk Hollow Road, (Little Creek Behavioral Center) for a disturbance. Upon arrival, I met complainant, Julie Tobey, who took me to a staff room. There I met victims, Amy Davis, who had a visible bruise on the left cheek below her eye and, later, victim Catherine Ellis, who was spit at and swung at, but not hit, by juvenile offender, (J1).

Both victims gave written statements, which are included in the case file. Ms. Davis advised she was struck in the face by J1's fist. Ms. Ellis advised she was spit at and that J1 tried to hit her, also, but J1 did not.

I spoke to J1. J1 told me she did not want to be there and would do other things to be taken to jail, because staff had lied to her and provoked her, saying she was leaving, when she was not allowed.

I called Juvenile Intake and was advised J1 could not be taken to juvenile detention. I advised staff at the facility of this report and how to get a copy.
