NARRATIVE

OFFICERS RESPONDED TO A RUNAWAY JUVENILE CALL AT 6501 W 12TH ST. UPON ARRIVAL, OFFICERS MADE CONTACT WITH PERCY ALLISON. MR. ALLISON ADVISED OFFICERS, AT APPROXIMATELY 0730 HOURS, JUVENILE 1 RAN AWAY. OFFICERS PUT OUT A BROADCAST TO HELP LOCATE JUVENILE 1 AND BEFORE OFFICERS LEFT THE SCENE, WALMART CALLED THE BUSINESS AND ADVISED JUVENILE 1 WAS CURRENTLY WITH THEIR ASSET PROTECTION OFFICERS.

OFFICERS RESPONDED TO WALMART AT 2700 S SHACKLEFORD AND MADE CONTACT WITH ASSET PROTECTION. ASSET PROTECTION OFFICERS ADVISED OFFICERS THAT JUVENILE 1 CAME INTO THE STORE AND TOLD THEM HE WAS A RUNAWAY FROM THE CENTERS FOR YOUTH AND FAMILY. OFFICERS THEN MADE CONTACT WITH JUVENILE 1. JUVENILE 1 ADVISED OFFICERS HE WAS FREEZING COLD AND WANTED TO BE TRANSPORTED BACK TO THE CENTERS. OFFICERS BEGAN TRANSPORT AND WHILE IN THE CAR, JUVENILE 1 STATED, HE AND A FEW OTHERS HAD A PLANNED TO ESCAPE THAT MORNING. JUVENILE 1 STATED SOMEONE PULLED THE FIRE ALARM AND HE JUMPED THE GATE AND RAN AWAY. OFFICERS ARRIVED AT THE CENTERS FOR YOUTH AND FAMILY WHERE JUVENILE 1 WAS RECEIVED BY EMPLOYEES.

NO FURTHER POLICE ACTION WAS TAKEN. MVR IN USE.
