Narrative

On 11/23/2020, at approximately 1601 hours, I was dispatched to make contact with Ms. Shanna Parker (Complainant) in reference to sexual misconduct occurring at 161 Skunk Hollow Road, Little Creek Behavioral Health.

Ms. Parker stated she resides in Arizona and is a Mentor/Advocate for JV1 (Victim). Ms. Parker stated she spoke to JV1 via phone on 11/21/2020 and was advised of some misconduct occurring at the institute. Ms. Parker stated she was given the impression a female staff allowed JV1 to make to unapproved phone call to her. Ms. Parker stated she did not have the staff members name but in a sense confirmed everything JV1 advised her of. Ms. Parker stated JV1 is from Arizona and is housed at the institution Little Creek Behavioral. Ms. Parker stated JV1 advised a staff member by the name Mr. Silva inappropriately rubbed his body on hers. Ms. Parker stated she was advised there was an investigation in the incident by the facility and Mr. Silva was found innocent of any wrong doings. Ms. Parker stated she was also advised of excessive force being used on the children by staff members. Ms. Parker stated JV1's attorney has also had problems making contact with JV1 due to the staff members not allowing her to speak to anyone.

Ms. Parker was provided a report number via phone and advised on how to obtain a copy of the report. Investigator Fowlkes was notified of the incident. A suspect child abuse form was completed and faxed to Arkansas State Police.
