**Narrative**

On 12/14/2020, at approximately 1006 Hours, is given a call for service in reference to a sexual offence that occurred at 161 Skunk Hollow Rd.

I spoke with Mrs. Angela Bright-Fontana (complainant) via phone. Mrs. Fontana informed me that her daughter JV1 (victim) was living at Little Creek Behavioral Center from March 2020 until October 2020, when she was involved in a sexual assault.

Mrs. Fontana stated that JV1 was sleeping in her bed when her roommate, JO1 (offender), woke her up by lying on top of her. JO1 pulled JV1's pants down and asked her if she wanted to have sex. JO1 then licked JV1's vaginal area. JV1 began yelling to get attention of staff members, who then showed up.

Mrs. Fontana informed me that JV1 is deaf and believes that she was targeted due to her disability.

Mrs. Fontana also informed me that JV1 was assaulted by a staff member while staying at Little Creek Behavioral Center. Mrs. Fontana stated she did not know any information about the staff member other than her name was "Tamika". Mrs. Fontana stated that "Tamika" choked and restrained JV1. Mrs. Fontana stated that "Tamika" threatened to choke JV1 on October 24.

I provided Mrs. Fontana with this report number for her records and informed her how to obtain a copy.

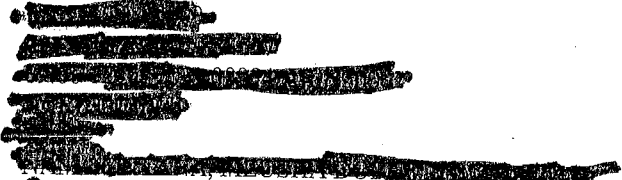
