On January 10, 2021 at approximately 0800 hours I (Officer Swiger) was dispatched to an abandoned house right next to Mr. Clean Car Wash for a runaway, by the name [REDACTED], that had left Millcreek Behavioral Facility approximately 2230 hours the night before called in by Ms. Veronica Eddington.

Upon arrival I made contact with Mr. Gary Sneed which was there waiting on my arrival to enter the abandoned building. I entered the building and cleared it. There was no sign that [REDACTED] had been there. I asked Mr. Sneed how he had got his information. Mr. Sneed stated that [REDACTED] along with another juvenile, [REDACTED] had planned to run away together and head towards an abandon house by the tobacco store. Mr. Sneed stated that as the juveniles were attempting to jump over the fence at the back of the facility they had caught [REDACTED] and questioned him on where they were going and what they were planning.

I went to the Millcreek Facility on 204 Cadiz Street and made contact with Mr. [REDACTED] to further question him due to the fact where they were looking didn't add up to what he had told them. [REDACTED] stated [REDACTED] and himself were planning on staying at the old abandoned tobacco store and then planning on stealing a Post Office Mail car and head to Little Rock. Immediately I knew we looked in the wrong place so I asked for a print out of [REDACTED] and a picture along with description of what he was wearing last.

Due to the information I received I started towards the old tobacco store to search

it. I advised dispatch to see if they could contact a key holder for the old building so I could confirm [REDACTED] was not in there. Dispatch made contact with the key holder, Mr. Fay Pierce, and he unlocked the property for me to clear the building. The building was secure and there appeared to be no sign that [REDACTED] was or had been there.

I advised Mr. Sneed of my findings and told him that I would get [REDACTED] entered in on ACIC as a runaway/missing person so that other departments in Arkansas could be aware. I also advised Mr. Sneed that I would be on the look out for Mr. [REDACTED] while I was patrolling today, he thanked me and went on his way. I advised dispatch then checked back in service.






