On February 10, 2021 at 1358 hours, I was dispatched to the area of Industrial Drive and Highway 79 in reference a juvenile escaping from Millcreek of Arkansas.

Upon arrival I made contact with Nurse Sharon Smith. Mrs. Smith stated that [REDACTED] has ran from the facility and is in the woods across the highway. Mrs. Smith stated that there are employees that are in the woods attempting to locate him. Mrs. Smith stated [REDACTED] was last seen wearing a black sweat shirt and dark sweat pants and is approximately six foot two inches tall and weighs 236 pounds. Mrs. Smith handed me a copy of his information sheet and a picture of the juvenile. I advised Mrs. Smith to let the Fordyce Police Department know if they locate [REDACTED] before we do.

At 1450 hours I was advised by dispatch that Mrs. Smith had called the Fordyce Police Department and advised they have located [REDACTED] and is back in their custody.

Narrative - Swiger, Canaan - 2/10/2021 3:00:00 PM (Initial)




