## NARRATIVE

A DISTURBANCE/FIGHT WAS REPORTED AT THE LOCATION BY RESIDENTS. THE JUVENILE/VICTIM ADVISED SHE WAS RANDOMLY JUMPED ON AND ATTACKED BY ANOTHER JUVENILE/SUSPECT AT THE LISTED LOCATION. SHE ADVISED SHE DEFENDED HERSELF WHEN ATTACKED BUT DID NOT HAVE ANY INJURIES OR VISIBLE MARKS. SHE ALSO REFUSED MEDICAL. SHE STATED SHE WISHED TO PURSUE CHARGES AND IT WAS SOON DISCOVERED SHE WAS CURRENTLY AT THE LOCATION ON A COURT ORDERED MANDATE FOR PROBATION. I THEN WENT TO ATTEMPT TO SPEAK WITH THE SUSPECT. INITIALLY SHE DID NOT WISH TO SPEAK TO ME BUT LATER DECIDED SHE WANTED TO. SHE ADMITTED THAT SHE DID ATTACK THE JUVENILE VICTIM BECAUSE SHE WAS TALKING MESS ABOUT HER AND ENOUGH WAS ENOUGH. I ADVISED HER THAT WAS UNNECESSARY AND TO REFRAIN FROM SUCH BEHAVIOR. SHE SAID SHE DID NOT NEED MEDICAL ATTENTION BUT SAID SHE WAS HURTING. THERE WAS A SMALL AMOUNT OF BLOOD ON THE FLOOR NEAR WAS SHE WAS SITTING. THE STAFF HAD BEEN NOTIFIED OF THE INCIDENT AND CONTACT WAS MADE WITH CANTRELL (CONTACT/WITNESS/STAFF) WHO MADE A STATEMENT CONSISTENT WITH BOTH PARTIES. SHE SAID THE SUSPECT JUMPED ON THE VICTIM BECAUSE OF FABRICATED WORDS WHICH HAD BEEN EXCHANGED IN THE FACILITY. THE STAFF ADVISED ACTIVE VIDEO SURVEILLANCE SHOULD HAVE CAPTURED THE INCIDENT IF THE NEED ARISES. I ATTEMPTED TO MAKE CONTACT WITH THE FATHER (JOSE GATES/479-270-9396) OF THE VICTIM WITH NEGATIVE RESULTS. NOTHING FURTHER.
