Narrative - Swiger, Canaan - 2/24/2021 7:22:00 PM (Initial)

On February 24, 2021 at approximately 1922 hours I (Officer Swiger) was dispatched to Millcreek of Arkansas in reference to two male juveniles that had escaped from the facility and ran into the woods called in by Ms. Laura Lindsey.

Upon arrival I made contact with the nurse station which stated that along with had escaped from there barracks and ran into the woods across Highway 79 by the old Russell building. Ms. Lindsey stated that was wearing a red jacket with black pants and was wearing a black jacket with blue jeans and white shoes. I got the printouts of both of the juveniles and responded to the area of Highway 79 at the old Russell building. I searched around the area but was unable to locate either of the juveniles in the immediate area. Due to the fact the woods that they had ran into were in the county I did not continue to proceed. I advised the Millcreek workers that I would patrol on Highway 79 to see if they would come out of the woods so they could be apprehended.

After searching I was unable to locate, I called the Nurse station and spoke with Ms. Lindsey and advised her that if she had seen them come out of the woods to let us know but we would do extra patrol on Highway 79 tonight.
