Narrative - Swiger, Canaan - 3/6/2021 10:21:00 AM (Initial)

On March 6, 2021 at approximately 1021 hours I (Officer Swiger) was dispatched to Millcreek of Arkansas in reference to three male subjects that had escaped the facility called in by Nurse Pamela Edwards.

Upon arrival I made contact with Nurse Edwards which stated that they had caught one of the male juveniles. Nurse Edwards identified him as [REDACTED]. [REDACTED] was contained in Millcreek's van and transported back to Millcreek. Nurse Edwards stated the other two boys were last seen around the highway but ran off into the woods. She identified the other two male juveniles as [REDACTED] and [REDACTED].

I patrolled around the area of the last seen location of the juveniles to attempt to locate them. I noticed two male juveniles walking in the Johnsons warehouse that matched the description so I pulled over to make contact. I confirmed that the two male subjects were the juveniles that had escaped so I placed them in the back of my unit and transported them back to Millcreek. All Juveniles were secured at this


