Narrative & Statements

Narrative - Rhodes, Michael - 3/23/2021 (Initial)

On March 23, 2021 at 1300 hours, I was given a message to call Justin Wendell with risk management for Millcreek of Arkansas. I made contact with Mr. Wendell by phone and he stated that he was needing to make a report of the two juveniles that have escaped. Mr. Wendell stated that he was called by a case manger from Dallas Texas in reference to the juveniles. Mr. Wendell stated that there is not a updated description of the juveniles but would fax me a information sheet of both juveniles along with a picture that are on file.

At approximately 1510 hours, I made contact with Mr. Wendell again by phone. I advised Mr. Wendell that I haven't received any information of the juvenile by fax yet. Mr. Wendell stated that the fax failed and I advised Mr. Wendell I needed the information before I am able to make a report. I advised Mr. Wendell to send it by email. Mr. Wendell stated that he will send it as soon as he gets off the phone.

At 1542 hours I received an email from Mr. Wendell with the basic information of the juveniles along with a black and white picture. I called Mr. Wendell back to get the information of the hair, eye color, weight and a better clothing description. Mr. Wendell stated that he didn't have that information but would call back.

At 1715 hours Mr. Wendell sent a email with the juveniles information.

I was advised by dispatch that on March 22, 2021 at 1524 hours Tracy Crain (employee of Millcreek of Arkansas) called the Fordyce Police Department in reference to two patients that have left from the facility. Mr. Crain reported the two subjects left the facility about 1500 hours with one wearing blue and white camo. And the other patient as tall light skinned with braids and no other information. Mr.
