Narrative

On March 25, 2021, at approximately 1209 hours, I was dispatched on a sexual offense call for service in reference to an incident that occurred at 161 Skunk Hollow Rd. Sarah Kincaid (complainant), with Arizona Child Abuse Hotline, needed to report an incident which happened between two minors.

I made contact with Ms. Kincaid, via phone, who advised she received a call from Melissa Moreno (others involved) stating while her daughter, JV2 (victim), was at Little Creek Behavioral (161 Skunk Hollow Rd) an incident occurred with another juvenile. Ms. Moreno stated JV2 advised her between October 29, 2019 and October 29, 2020, JV1 (offender) started touching her without giving a description of how he actually touched her. JV2 stated as time progressed JV1 got to the point where he penetrated her vagina with his penis.

Ms. Kincaid stated Ms. Moreno could not advise when the incident occurred. She just stated it happened while JV2 was ten (10) years old. Ms. Moreno did not have any information for JV1 except a first name.

Ms. Kincaid was advised of the incident number.
