On 04/23/2021 I Officer Johnson was dispatched to the station for a walk-in Battery 3rd report.

Upon my arrival I made contact with Jalyn Lynch. Mr. Lynch states that he was walking out of the classroom at Perimeter Behavioral Health 1521 Albert St. where Mr. Lynch is employed. He was assigned to the outside area to assist a co-worker with processing and redirecting the resident [REDACTED]. Once he made it to the area he could see the co-worker had [REDACTED] under control but still resisting. Once [REDACTED] was let go he began to storm up and down the hallways mouthing off and verbal aggression then he stopped and started to point his attention towards Mr. Lynch. That's when Lynch walked towards [REDACTED] and both were face to face. That's when Mr. Lynch states that [REDACTED] sucker punched him in the face with his fist near his lip area. I could see bruising in that area.
