Narrative - Rhodes, Michael - 4/29/2021 (Initial)

On Thursday April 29, 2021 at approximately 1333 hours I, Officer Brewer was dispatched to Millcreek of Arkansas at 1810 Industrial Dr. for two runaways. Upon my arrival I made contact with Ms. Shakendra Montgomery. Ms. Montgomery stated that they were at lunch in the cafeteria when two white male juveniles ran out and jumped over the fence behind the cafeteria. One male was [REDACTED] [REDACTED] is 17 and is wearing red sweat pants and a white tee shirt. [REDACTED] also has faded blue hair. The other male was [REDACTED] [REDACTED] is 14 and is wearing blue jeans and a light blue shirt. Ms. Montgomery stated that they were last seen at 1315 hours.
