Narrative & Statements

Narrative - Mcelroy, Chris - 5/8/2021 (Initial)

On Friday May 7, 2021 at approximately 6:08 p.m., I, Officer C. McElroy #292, was dispatched to 600 North 7th Street (Perimeter Behavioral Hospital) in reference to two juvenile patients that had jumped the fence and fled the facility. Contact was made with the complainant, Chantel Lewis, who advised a black male juvenile [REDACTED] and a white male juvenile [REDACTED] jumped the fence on the west side of the building during a recreation break and fled south. [REDACTED] and [REDACTED] are both Wards of the State and were awaiting placement into foster care. [REDACTED] was last seen wearing black sweat pants, white tee shirt and black slide shoes and [REDACTED] was last seen wearing gray pants, gray tee shirt and unknown color slide shoes.

Lewis gave a hand written statement to the events. [REDACTED] and [REDACTED] were entered into N.C.I.C./A.C.I.C., ([REDACTED] and [REDACTED]). Officers searched the area but did not locate them. Photos were obtained of both juveniles and attached to this report.
