Narrative

On May 26, 2021, at approximately 1045 hours, I was dispatched on a juvenile abuse report for Tara McDaniel (complainant) with ASP Crimes Against Children. Ms. McDaniel wanted to report an incident which occurred at 161 Skunk Hollow Rd (Little Creek Behavioral Center).

I made contact with Ms. McDaniel, via phone, who advised on May 11, 2021 an incident between JV1 (offender/victim) and an employee, Temeka Berry (offender/victim) occurred. Ms. McDaniel stated they were informed JV1 started trying to bite and hit Ms. Berry when Ms. Berry, being alone with no help at the moment, restrained JV1 by pinning him down on the floor until help could arrive. Berry placed one of her arms across JV1's back when JV1 yelled he couldn't breathe. As soon as JV1 advised he couldn't breathe Ms. Berry immediately released JV1, backing off when JV1 proceeded to start fighting again. By this time more employees arrived and they were able to get JV1 placed into a pod.

Ms. McDaniel stated they were informed Ms. Berry's lip was cut by JV1, but has since healed up.

Ms. McDaniel was advised of the incident number.
