NARRATIVE

OFFICERS RESPONDED TO THE LISTED CALL AT 6501 WEST 12TH STREET IN REFERENCE TO A BATTERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH, PATRICIA SHAVERS, WHO STATED THAT JUVENILE 1 STATED THAT SHE WAS LEAVING TODAY ON HER OWN OR IN A BODY BAG. MS. SHAVERS, TONY JACKSON, AND ERICO ABERNATHY SECURED AND PLACED JUVENILE 1 INTO ISOLATION WHEN SHE TRIED TO CHOKE HERSELF WITH A FACE MASK. WHEN SECURING JUVENILE 1, MS. SHAVERS STATED THAT JUVENILE 1 SWUNG HER FIST TOWARDS HER FACE, BUT DID NOT MAKE CONTACT. OFFICER MADE CONTACT WITH MS. JACKSON WHO STATED THAT WHILE SECURING JUVENILE 1, SHE PUNCHED HIM IN THE CHEST WITH HER FIST AND KICK HIS KNEES WHEN SECURING HER ON THE GROUND FOR SEDATION. OFFICERS MADE CONTACT WITH MR. ABERNATHY WHO STATED THAT JUVENILE 1 KICKED HIS LEGS WHILE SECURING HER ON THE GROUND FOR SEDATION. OFFICERS MADE CONTACT WITH JUVENILE 1 WHO STATED THAT SHE WAS UPSET THAT AN UNKNOWN STAFF MEMBER USED A TRIGGER WORD FOR HER. JUVENILE 1 STATED SHE WENT TO HER ROOM TO TRY TO KILL HERSELF WITH HER FACE MASK, BY WRAPPING THE STRINGS AROUND HER NECK. JUVENILE 1 STATED THAT SHE PUNCHED STAFF MEMBERS IN SELF-DEFENSE TO NOT BE SEDATED. ALL PARTIES HAD NO VISIBLE INJURIES AND REFUSED MEDICAL TREATMENT. MS.
