Narrative - Manning, Mallory - 5/28/2021 (Initial)

I, Det. Manning 272, made contact with complainant, Jessica Hutson on 05/28/2021 via phone. Hutson's son, victim [REDACTED] is currently residing at Perimeter Behavioral Health located at 600 North 7th Street in our city. Jessica stated that she was contact by a Perimeter employee who advised her that an incident took place between her son and another juvenile male Monday Night(05/24/2021) and that they were looking into it and would contact her with more information the following day. Jessica stated she received a call from the CEO of the company and was advised that [REDACTED] disclosed to an employee that the older juvenile male, identified as [REDACTED] had told him to sneak out and come to his room that night and he would teach him a "special game" to help him "get over his fears". [REDACTED] did actually sneak out of his room and went two doors down to [REDACTED] room after lights out. [REDACTED] disclosed that once [REDACTED] explained the "special game" to him he told him NO several times but eventually gave it to him. [REDACTED] disclosed that [REDACTED] turned him around, pulled his pants down, and rubbed his penis all over his bottom area. [REDACTED] did not disclose any penetration just skin to skin contact. When the incident was over [REDACTED] left [REDACTED] room and immediately went to get a worker to tell them what happened.

CACD(Sherrice Vales) completed a forensic interview with [REDACTED] today where he did make a disclosure.

DPA Mike Snell advised to refer to the report to Juvenile.
