I, Det. Manning 272, made contact with complainant, Jessica Hutson on 05/28/2021 via is currently residing at Perimeter Behavioral Health located at 600 North phone. Hutson's son, victim 7th Street in our city. Jessica stated that she was contact by a Perimeter employee who advised her that an incident took place between her son and another juvenile male Monday Night(05/24/2021) and that they were looking into it and would contact her with more information the following day. Jessica stated she received a call from the CEO of the company and was advised that disclosed to an employee that the older juvenile male, identified as had told him to sneak out and come to his room that night and he would teach him a "special game" to help him "get over his fears". did actually sneak out of his room and went two doors down to room after lights out. explained the "special game" to him he told him NO several times but eventually gave it to him. him NO several times but eventually gave it to him. d pants down, and rubbed his penis all over his bottom area. disclosed that I turned him around, pulled his did not disclose any penetration just skin to skin contact. When the incident was over left room and immediately went to get a worker to tell them what happened.

CACD(Sherrice Vales) completed a forensic interview with today where he did make a disclosure.

DPA Mike Snell advised to refer to the report to Juvenile.
