
Narrative - Hubanks, Chad - 5/30/2021 4:17:00 PM (Initial)

On May 30, 2021 at approximately 1617 Hours, I was dispatched Mill Creek for a report of a battery. Upon arrival I spoke with [REDACTED] and [REDACTED] stated that her area has bed bugs and that the staff was aggressive towards her. Ms. [REDACTED] stated that a staff member pushed her down to the floor and caused a bump on her forehead. [REDACTED] stated that she had refused to come inside which aggravated the staff member in which she does not know the name. I was unable to see any marks on [REDACTED] forehead. I advised [REDACTED] that a report would be filed. I spoke with Nurse Jody Bailey and she stated that she was not informed of any incident that had occurred. Ms. Bailey spoke with several employees about the incident in which stated that they had not known of any incident. Ms. Bailey advised me that [REDACTED] has stated that if she calls the police, that they would take her to a different place to stay and that she has tried several times to get out of the facility. I called the child abuse hotline and was informed that this incident did not meet the criteria for them to take the case. Reference number#3086141
