Narrative - Brewer, Orlando - 7/8/2021 (Initial)

On Thursday, July 8, 2021 at approximately 1621 hours I, Officer Brewer was dispatched to Mill Creek of Arkansas on Industrial Dr. for a male threatening the staff. Upon my arrival I made contact with Mr. Justin Wendell. Mr. Wendell stated that a male called the boys wing cussing and threatening the nurses about his son [REDACTED] being at the facility. Mr. Wendell stated that male never gave his name but stated that he was coming to get [REDACTED] and take him away from the facility. The male stated that he lives in Malvern and he was coming today to get [REDACTED]. Mr. Wendell stated that he spoke with [REDACTED] mother and case worker to let them know what was going on with [REDACTED]. Mr. Wendell then stated that the male that called left his number 870-678-3599 but not a name. Mr. Wendell then advised that the only person on [REDACTED] list was his mother Ms. Tonya Berry and his case worker Ms. Elizabeth Mahan.
