**Narrative & Statements**

**Narrative - Brewer, Orlando - 7/23/2021 (Initial)**

On Thursday, July 23, 2021, at approximately 0008 hours I, Officer Brewer was dispatched to Millcreek of Arkansas on Industrial Dr for two male escapees. Upon my arrival I made contact with Nurse Laura Linzsey. Nurse Linzsey stated that the two males [REDACTED] and [REDACTED] were last seen at 0000 hours, running towards the woods from the gazebo that's on campus. Nurse Linzsey nor any of the other staff knew what [REDACTED] or [REDACTED] were wearing. After speaking with Nurse Linzsey, she handed me a picture and an information sheet on both [REDACTED] and [REDACTED]. I then went out to search for the two subjects and didn't find them.

At approximately 0252 I, Officer Brewer was out patrolling when I saw two people walking South on HWY 79 in the North bound lane. I then went and parked at the Fordyce Travel Center. After sitting at the Fordyce Travel Center for about three minutes when I noticed the two people walking up to the Exxon across the street. When seeing the two people walking to Exxon, I noticed that they matched the picture I was given by Nurse Linzsey at Millcreek of [REDACTED] and Mr. [REDACTED]. I then checked out at Exxon. The cashier Ms. Pamela Berry looked at me and advised me that the two male subjects that ran from Millcreek were in the restroom. I waited until [REDACTED] and [REDACTED] came out of the restroom. I then made contact with [REDACTED] and [REDACTED] and asked the two where have they been? [REDACTED] replied, "We were just out walking around." I then told both [REDACTED] and [REDACTED] to turn around and placed them both under arrest. Both [REDACTED] and [REDACTED] were placed in the back seat of my patrol car and then transported back to Millcreek.
