### **Narrative**

On August 09, 2021 at approximately 1618 hours, dispatch advised I had a call for service from Ms. Susie Roberts from CAC needing to make a report regarding sexual assault. I made contact with Ms. Roberts via telephone.

Ms. Roberts advised that the child abuse hotline had received a report of an alleged sexual offense that had taken place at little creek behavioral center (161 Skunkhollow Rd) between a male juvenile patient and a female staff member back in February 2021. The juvenile has since returned home with his mother in Georgia and the female staff member, Ms. Catherine Ellis (offender) was terminated in April 2021. Ms. Roberts advised that the juveniles mother, Ms. Markesha Bostic (others involved) found explicit photographs in the juveniles phone from Ms. Ellis. It was stated that Ms. Bostic advised the child abuse hotline that the juvenile stated he and Ms. Ellis had engaged in sexual intercourse while he was a patient of little creek behavioral and she has been sending him money on cashapp. A report has been made with the child abuse hotline. The reference number is 2102080.

Note: I have nothing for this case file at this time.
