On August 15, 2021 at approximately 1556 hours this officer, John Cutrell, was dispatched to Mill Creek on Industrial Drive for several kids running from the facility.

Upon arrival I made contact with the nurses' station to get the information on the subject that ran. Nurse Shevaun Eason gave the information on the subjects that ran and an area of where they ran too.

This officer checked the are and was unable to locate the kids. While at the office entering the subjects into ACIC, Mill Creek called the Police Department to inform them they have two of the subjects back at the facility. Approximately 10 minutes later this officer heard on the radio that Dallas County Deputies called in that there were three juvenile males walking down Highway 79 and Green Street.

This officer located the kids walking down Highway 79 and placed them in the back seat of my patrol car. I escorted the kids back to Mill Creek and turned them over to the care takers.

All of the subject that ran from Mill Creek were back in the custody of Mill Creek care takers.
