

Narrative - Brewer, Orlando - 8/23/2021 (Initial)

On Friday, August 20, 2021 at approximately 2156 hours I, Officer Brewer spoke with Ms. Nicole Stonis by phone. Ms. Stonis stated that her daughter [REDACTED] arrived at Millcreek on August 9, 2021, where she had been bullied since. Ms. Stonis stated that [REDACTED] told her that her roommate grabbed both of her arms and pulled her off the bed. Ms. Stonis stated that [REDACTED] did an incident report at Millcreek but none of the staff did anything about it. Ms. Stonis then stated that [REDACTED] said that she didn't feel safe there any more and that she hadn't been eating nor sleeping. Ms. Stonis then stated that she was driving from Chicago to come get [REDACTED] from Millcreek.

I then spoke with [REDACTED] on Saturday, August 22, 2021. [REDACTED] stated that everything that she told her mother was right. [REDACTED] stated that her roommate grabbed both of her arms and pulled her out of the bed. [REDACTED] stated that she had to do an incident report but no one followed up or did anything about it. [REDACTED] then stated that a group of girls came to her yelling saying that she had chores to do and if she didn't then nobody was going to the talent show. [REDACTED] also stated that she hasn't been eating or sleeping. [REDACTED]
