**Narrative - Brewer, Orlando - 8/22/2021 (Initial)**

On Friday, August 20, 2021 at approximately 1952 hours I, Officer Brewer was dispatched to the Dallas County Medical Center. Upon my arrival I made contact with Nurse Leigh Adams. Nurse Adams stated that a patient from Millcreek of Arkansas, by the name of [REDACTED] had been admitted for sexual assault. I then made contact with [REDACTED] and a staff member of Millcreek, Ms. Domeki Miller.

[REDACTED] stated that on Monday, August 16, 2021 during the day, but after dinner, she went to the bathroom and a boy was in there. [REDACTED] stated that the boys' name was [REDACTED]. [REDACTED] stated that [REDACTED] grabbed her arm and pulled her back when she was trying to walk away. Ms. [REDACTED] then stated that after [REDACTED] pulled her back in the bathroom, Mr. [REDACTED] pulled her pants down and began having sex with her. [REDACTED] stated that she yelled no and stop multiple times and no one heard her. Ms. [REDACTED] stated that she didn't give consent to having sex. I then asked Ms. [REDACTED] why did she wait until now to come forward? [REDACTED] replied, "I was scared because the staff during the week would retaliate, so I wanted to tell

someone I could trust." [REDACTED] then stated that she waited to tell the weekend crew because she didn't trust anybody else.

Ms. Miller stated that Millcreek was doing their own investigation. Ms. Miller also stated that the staff at Millcreek had statements from patients and the staff from Haley House where [REDACTED] and [REDACTED] reside.

Dr. Nasir Zareen from the Dallas County Medical Center performed a sexual assault kit. Dr. Zareen then gave the kit to Nurse Adams who then signed the kit over to this officer. The kit was then placed into evidence.

On Saturday, August 21, 2021 at approximately hours I, Officer Brewer made contact with [REDACTED]. [REDACTED] stated that he had no contact with Ms. [REDACTED] at all on Monday. [REDACTED] also stated that he hasn't had any contact with [REDACTED] within the last week. [REDACTED] stated that he was in his room all day. [REDACTED] then stated that he had no contact with anyone on the girl's side at all.

I then spoke with Mr. Andre Cameron a staff member. Mr. Cameron stated Ms. [REDACTED] told them that she was lying about the whole thing because [REDACTED] hasn't shown her any attention since last week.


