



Narrative - Brewer, Orlando - 9/9/2021 (Initial)

On Thursday, September 9, 2021 at approximately 0014 hours, I Officer Brewer responded to Millcreek of Arkansas. Upon my arrival I spoke with Nurse Laura Linzsey. Nurse Linzsey stated that after they found the escapees at 2022 HWY 79 N. they received a call from Ms. Ruth Clayton's daughter Ms. Tammy Wills. Ms. Wills called and stated that her mother's phone had been pinging at Millcreek. Nurse Linzsey stated that after talking with Ms. Wills she found the phone on [REDACTED]. Nurse Linzsey stated that [REDACTED] had the phone and was one of the escapees from earlier in the day. I advised Nurse Linzsey to leave the phone at the main office.
